General Terms and Conditions			
QA 1	Machining suppliers must furnish a Certificate of Conformance with each shipment. As applicable, each shipment must also include an Inspection Report, Material Certifications and processing certifications.		
QA 2	A First Article Inspection Report shall be submitted to TDA prior to the beginning of production or maintained at supplier's facility. The supplier assumes all financial responsibility for replacement, rework, and material without FAIR approval from TDA. The FAIR may be performed in AS9102 format or in the supplier's equivalent format.		
QA 3	Any delay in shipment must be communicated to TDA in writing as soon as the delay is known by the supplier.		
QA 4	Any change to the contract requirements by the supplier must be approved by TDA in writing.		
QA 5	All information in the contract must be held in confidence by the supplier and no third-party request for information will be authorized unless instructed in writing by TDA.		
QA 6	In addition to our right of access, the supplier agrees to the right of access for our customers or regulatory agencies to all facilities and records in the performance of this contract. All documents to be retained for 15 years minimum unless otherwise stated on the PO. Supplier must contact TDA after 15 years for record disposition requirements.		
QA 7	Manufacturers or machine shops must have a quality system in compliance to AS9003, AS9100, or ISO9001:2015 as applicable by our customer.		
QA 8	Suppliers are required to notify TDA prior to transferring any work to a new facility. Supplier must notify and obtain approval from TDA for any change in product, process or process definition.		
QA 9	Suppliers must notify TDA of any nonconforming product prior to shipment.		
QA 10	Suppliers must obtain TDA's approval for any shipment of nonconforming material. The approval must be in writing and accompany the parts.		
QA 11	Suppliers must flow down to sub-tier suppliers the applicable requirements in the purchasing documents, including key characteristics where required and positive FOD control processes		
QA 12	Suppliers to comply with Executive Order E13224. Supplier shall not engage in any transaction of any type with persons, businesses or organizations who commit, threaten to commit or support terrorism.

For Calibration/Testing suppliers, the following are the minimum requirements:

Supplier must maintain a QMS per ISO9001:2015, ISO 17025, ANSI Z540, and/or NADCAP. Actual data must be supplied. QA 3, QA 4, QA 5, QA 6, QA 8, QA 9, QA 10, QA 11, QA 12, QA 13, QA 14, QA 15, QA 16
